#### **RESOLUTION NO. CRA-RES-2019-03**

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE MULBERRY COMMUNITY REDEVELOPMENT AGENCY RELATING TO FINANCE; ARTICULATING THE PROCEDURE FOR AMENDING AND FINALIZING THE FISCAL YEAR 2018-2019 BUDGET; AUTHORIZING CERTAIN ADMINISTRATIVE AMENDMENTS TO THE FISCAL YEAR 2018-2019 BUDGET; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the Mulberry Community Redevelopment Agency ("CRA") is a dependent special district of the City of Mulberry, Florida as defined by the *Uniform Special District Accountability Act*, Section 189.012(2)(b), Florida Statutes (2018); and

**WHEREAS**, the CRA's redevelopment trust fund is a dependent major fund of the City of Mulberry; and

WHEREAS, the Board of Commissioners of the Mulberry CRA desires to articulate a budget amendment procedure and to authorize the CRA Director and the City of Mulberry Finance Director to effectuate an orderly close-out of the financial books and records of the CRA for Fiscal Year 2018-2019; NOW, THEREFORE,

Be it resolved by the Board of Commissioners of the Mulberry Community Redevelopment Agency:

### Section 1. Recitals.

The above referenced recitals and "whereas" clauses are true and correct and incorporated into this Resolution.

# Section 2. <u>Authority and Procedure for Fiscal Year 2018-2019 Budget</u> Amendments.

(a) The City of Mulberry's Finance Director shall have the authority to transfer appropriations made in the Redevelopment Trust Fund from one line item to another line item of the CRA's Fiscal Year 2018-2019 budget, upon approval of the CRA Director, so long as the total appropriations of the Redevelopment Trust Fund shall not be increased or decreased thereby. For the Fiscal Year 2018-2019 budget, transfers shall reflect the CRA's actual expenditures during Fiscal Year 2018-2019, the unexpended balances from CRA projects approved in Fiscal Year 2018-2019 that are awaiting completion, and any allocations or reallocations of unexpended Redevelopment Trust Fund appropriations to statutorily eligible

projects as required by the Community Redevelopment Act of 1969.

- (b) Transactions affecting the total amount of appropriations in the Redevelopment Trust Fund for Fiscal Year 2018-2019, other than those previously authorized by the CRA, shall require the approval of the CRA Board of Commissioners which shall be by motion or resolution as required by general law. All transactions are subject to applicable restrictive statutes or ordinances, including those authorizing the issuance of any outstanding bonds, if any.
- (c) Changes to the budget made by the Finance Director and the CRA Director, other than correction of scrivener's errors, shall be reported to the CRA at its next regularly scheduled meeting. Amendments to the budget shall be made in compliance with Section 189.016(6), Florida Statutes (2018) and the procedures in this resolution. A final amended budget for Fiscal Year 2019-2020 shall be developed by the CRA and its staff on or before November 29, 2019 and a copy shall be posted on the CRA's website upon finalization or CRA approval, whichever is required by law.

Section 3. <u>Effective Date.</u> This resolution shall take effect immediately upon approval.
