

NOTICE OF PROPOSED ENACTMENT

Notice under § 166.041(3)(a) of the Florida Statutes is hereby given that:

ORDINANCE NO. ORD-2020-05: AN ORDINANCE RELATING TO MUNICIPAL FINANCE; AMENDING SECTIONS 19-151 AND 19-155 AND CREATING SECTION 19-164 OF THE CODE OF ORDINANCES OF THE CITY OF MULBERRY, FLORIDA; CORRECTING SCRIVENER'S ERRORS; REVISING THE DEFINITIONS OF WASTEWATER EQUIVALENT RESIDENTIAL CONNECTION (ERC) AND WATER EQUIVALENT RESIDENTIAL CONNECTION (ERC); REVISING THE AMOUNT OF CAPITAL RECOVERY CHARGES FOR CONNECTION TO THE CITY OF MULBERRY'S WATER AND SANITARY SEWER SYSTEMS, COMMONLY KNOWN AS WATER AND WASTEWATER CAPACITY FEES; ESTABLISHING THE PRESUMED EQUIVALENT NUMBER OF WATER AND WASTEWATER RESIDENTIAL CONNECTIONS FOR COMMON WATER METER SIZES; CREATING A SUMMARY TABLE; AUTHORIZING FUTURE AMENDMENTS TO THE CITY OF MULBERRY'S WATER AND SEWER CAPACITY FEES TO BE MADE BY RESOLUTION IN COMPLIANCE WITH GENERAL LAW; INDEXING WATER AND WASTEWATER CAPACITY FEES TO THE FLORIDA PUBLIC SERVICE COMMISSION ANNUAL PRICE INDEX FOR WATER AND WASTEWATER UTILITIES; PROVIDING FOR CONFLICTS, SEVERABILITY, THE ADMINISTRATIVE CORRECTION OF SCRIVENER'S ERRORS, CODIFICATION AND AN EFFECTIVE DATE

shall be brought before the city commission of the City of Mulberry, Florida for public hearing during the commission's meeting scheduled for March 24, 2020 at 3:00 PM, City Hall, 104 South Church Avenue, Mulberry, Florida 33860. The public may inspect the proposed enactment at the commission's meeting and at Office of the City Clerk, City Hall, 104 South Church Avenue, Mulberry, Florida 33860 between the hours of 8:00 AM and 5:00 PM, Mondays through Thursdays, and 8:00 AM and 4:00 PM, Fridays, excepting holidays. Interested parties may appear at the commission's meeting and be heard with respect to the proposed enactment.

If a person decides to appeal any decision made by the commission with respect to any matter considered at such meeting, he or she will need a record of the proceedings, and, for such purpose, he or she may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
