

# NOTICE OF PUBLIC HEARING ON PROPOSED RESOLUTION TO DESIGNATE A BROWNFIELD AREA

Notice is given that the City Commission of the City of Mulberry, Florida proposes to adopt the following resolution:

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF MULBERRY, FLORIDA, DESIGNATING LAND SITUATE WITHIN THE CORPORATE LIMITS OF THE CITY OF MULBERRY AS A BROWNFIELD AREA FOR THE PURPOSES OF ENVIRONMENTAL REMEDIATION, REHABILITATION AND ECONOMIC DEVELOPMENT; PROVIDING FOR TERMS AND CONDITIONS OF THE DESIGNATION AND IDENTIFYING THE RESPONSIBLE PERSON FOR REMEDIATION AND REHABILITATION; PROVIDING FOR TRANSMITTAL OF THE DESIGNATION TO THE FLORIDA DEPARTMENT OF ENVIRONMENTAL PROTECTION; PROVIDING FOR AN EFFECTIVE DATE (GENERAL LOCATION: EAST OF STATE ROAD 37, SOUTH OF CARTER ROAD AND WEST OF CARTER PARK ENTRANCE ROAD; THE AREA COVERED BY THIS REQUEST IS ± 7.48 ACRES)

A public hearing on the proposed resolution will be held on July 6, 2021 at 6:00 P.M. in the City Commission Chambers, City Hall, 104 South Church Avenue, Mulberry, Florida 33860.

If a person decides to appeal any decision made by the City Commission with respect to any matter considered at the public hearing, he or she will need a record of the proceedings, and, for such purpose, he or she may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.

The City Commission may continue the public hearing to other dates and times as it deems necessary. Any interested party shall be advised that the date, time and place of any continuation of this or any continued public hearing may be announced during the hearing and that no further notices regarding this matter may be published.
