

# NOTICE OF PUBLIC HEARING ON PROPOSED ORDINANCE FOR UTILITIES RATE INCREASE

Notice is given that the City Commission of the City of Mulberry, Florida proposes to adopt the following Ordinance:

## ORDINANCE NO. ORD-2021-04

**AN ORDINANCE OF THE CITY OF MULBERRY, FLORIDA, RELATING TO UTILITIES; AMENDING CHAPTER 19, SECTIONS 19-16, 19-29, 19-37, 19-86, AND 19-155 OF THE CODE OF ORDINANCES OF THE CITY OF MULBERRY, FLORIDA; PROVIDING FOR AN INCREASE IN THE RATES, FEES AND CHARGES OF THE CITY FOR UTILITY SERVICES, INCLUDING CAPACITY FEES, TO ADJUST FOR INFLATION FOR RELEVANT PERIODS AND CONFORMING THE CODE OF ORDINANCES OF THE CITY OF MULBERRY; PROVIDING A PROCEDURE FOR ADJUSTMENT TO THE SCHEDULE OF RATES, FEES AND CHARGES OF THE CITY FOR UTILITY SERVICES BY RESOLUTION OF THE CITY COMMISSION OF THE CITY OF MULBERRY; CORRECTING SCRIVENER'S ERRORS IN SECTIONS 19-29 AND 19-37 OF THE CODE OF ORDINANCES OF THE CITY OF MULBERRY; PROVIDING FOR CONFLICTS, SEVERABILITY, CODIFICATION AND THE ADMINISTRATIVE CORRECTION OF SCRIVENER'S ERRORS; PROVIDING FOR AN EFFECTIVE DATE (SECOND AND FINAL READING).**

A public hearing on the proposed ordinance will be held on August 17, 2021 at 6:00 P.M. in the City Commission Chambers, City Hall, 104 South Church Avenue, Mulberry, Florida 33860.

If a person decides to appeal any decision made by the City Commission with respect to any matter considered at the public hearing, he or she will need a record of the proceedings, and, for such purpose, he or she may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.

The City Commission may continue the public hearing to other dates and times as it deems necessary. Any interested party shall be advised that the date, time and place of any continuation of this or any continued public hearing may be announced during the hearing and that no further notices regarding this matter may be published.
