Notice is hereby given that a SECOND READING and PUBLIC HEARING will be convened by the Mulberry City Commission on the following ordinance to amend the City's Capital Improvements Element / Capital Improvements Plan / 5-Year Capital Improvement Schedule to add the 4<sup>TH</sup> Avenue NE Nature Park Picnicking and Fishing and Southeast Pocket Park Playground projects to "Year Five" Fiscal Year 2023-2024:

ADOPTING AN UPDATE TO THE 5-YEAR CAPITAL  
IMPROVEMENTS PLAN OF THE CITY OF MULBERRY 2030  
COMPREHENSIVE PLAN; PROVIDING FOR SEVERABILITY;  
REPEALING CONFLICTING ORDINANCES AND PROVIDING  
FOR AN EFFECTIVE DATE**

The PUBLIC HEARING on the proposed ordinance will be held at 6:00 p.m. or as soon thereafter as it may be convened on Tuesday August 16, 2022, at City Hall, 104 South Church Avenue, Mulberry, Florida 33860 at which time the City Commission will consider its adoption into law. A copy of the Ordinance may be viewed or obtained from the City Clerk's office during regular business hours between 8 am and 5 pm, Monday through Thursday and between 8 am and 4 pm Friday, excluding holidays. All interested parties may appear at the meeting and be heard with respect to the proposed ordinance.

Section 286.0105 of the Florida Statutes provides that if a person decides to appeal any decision made by the board, agency, or commission with respect to any matter considered at such meeting or hearing, he or she will need a record of the proceedings, and that, for such purpose, he or she may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.

The City Commission may continue the public hearing to other dates and times as it deems necessary. Any interested party shall be advised that the date, time and place of any continuation of these or continued public hearings may be announced during the hearing and that no further notices regarding this matter may be published.
