

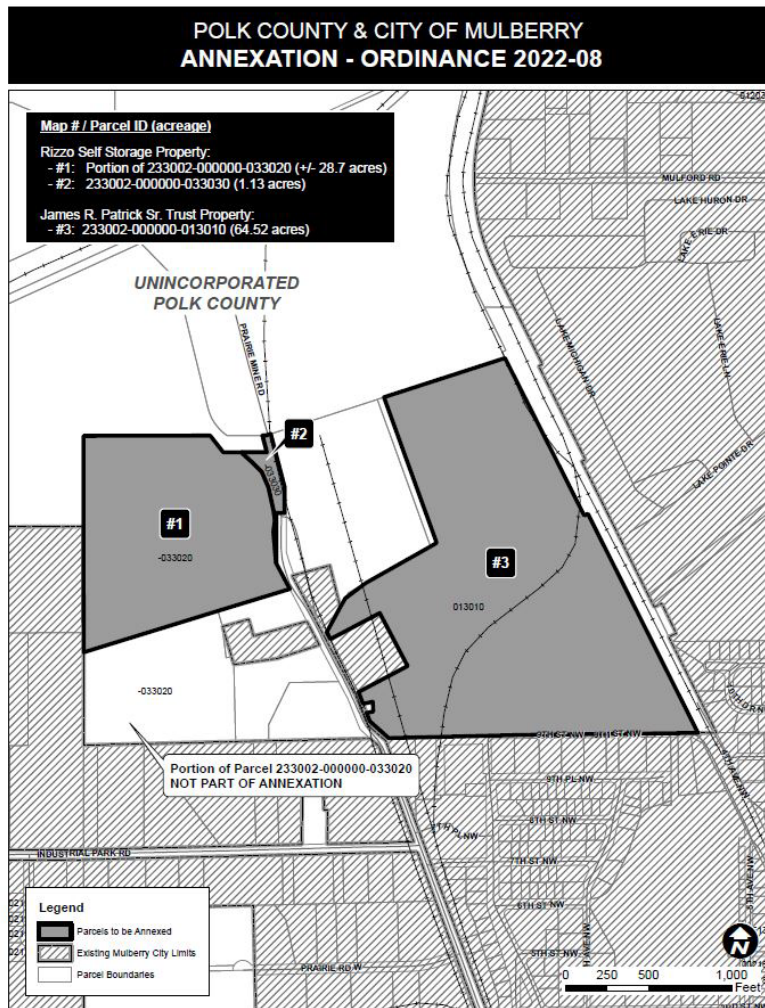
**PUBLIC NOTICE

Notice is hereby given that a **SECOND READING** and **PUBLIC HEARING** will be convened by the Mulberry City Commission on the following ordinance to annex property and redefine the boundary lines of the City of Mulberry to include such property:

ORDINANCE NO. ORD-2022-08

AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF MULBERRY, FLORIDA, SO AS TO INCLUDE THEREIN ADDITIONAL TERRITORY LYING CONTIGUOUS AND ADJACENT TO THE PRESENT BOUNDARIES OF THE CITY OF MULBERRY, FLORIDA; DESCRIBING SAID ADDITIONAL TERRITORY; REPEALING ALL ORDINANCES IN CONFLICT; PROVIDING AN EFFECTIVE DATE (GENERAL LOCATION: THE TERRITORY LIES NORTH OF THE INTERSECTION OF INDUSTRIAL PARK ROAD AND PRAIRIE MINE ROAD; THE AREA COVERED BY THIS REQUEST CONSISTS OF APPROXIMATELY 94.35 ± ACRES)

The PUBLIC HEARING on the proposed ordinance will be held at 6:00 p.m. or as soon thereafter as it may be convened on Tuesday November 1, 2022, at City Hall, 104 South Church Avenue, Mulberry, Florida 33860 at which time the City Commission will consider its adoption into law. A complete legal description by metes and bounds of the property to be annexed and a copy of the Ordinance may be viewed or obtained from the City Clerk's office during regular business hours from 8:00 a.m. to 4:30 p.m., weekdays. All interested parties may appear at the meeting and be heard with respect to the proposed ordinance.

Section 286.0105 of the Florida Statutes provides that if a person decides to appeal any decision made by the board, agency, or commission with respect to any matter considered at such meeting or hearing, he or she will need a record of the proceedings, and that, for such purpose, he or she may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.

The City Commission may continue the public hearing to other dates and times as it deems necessary. Any interested party shall be advised that the date, time and place of any continuation of these or continued public hearings may be announced during the hearing and that no further notices regarding this matter may be published.
