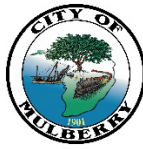
City of Mulberry
Demolition Permit Application Instructions

1. Demolition permit application must be completed with Parcel ID and Owner's name.
2. When the application is completely filled out it must be signed by Florida Public Utilities aka Central FL Gas. Send application to bsegree@cityofmulberryfl.com
3. When the application is completely filled out it must be signed by TECO. Contact 863-298-6055 or 813-635-1500 and choose prompt 4.
4. Contact Utility Customer Service at 863-452-1125 ext. 222 to have the water meter removed.
5. Call Sunshine Call One of Florida at 811 or 1-800-432-4770 to obtain a locate ticket number.
6. Water services must be cut and capped at the customer side of the meter box.
7. Contact Scott Walls, Installation & Maintenance at 813-892-9621 or scott.walls@ftr.com with Frontier for signatures **(COMMERCIAL ONLY)**.
8. The sanitary sewer lateral must be capped at the right-of-way / property line and concrete poured around the capped portion. The contractor shall contact Utility Services at 863-425-1125 ext. 222 to coordinate an inspection of the capping / removal of the water and sewer services. Inspection by Utility Services is required prior to backfilling. Sign-off will be provided at the time of inspection, if acceptable. The inspector will bring the demo permit application along with all required documents to the Building Department.

Upon completion of 1 – 8 above you will be notified by the City of Mulberry Building Department to obtain the permit.

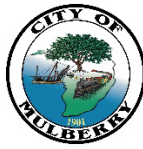

NOTICE: In addition to the requirements of this permit, there may be additional restrictions applicable to the property that may be found in the public records of this county, and there may be additional permits required from other governmental entities such as water management districts, state agencies, or federal agencies. Each BUILDING PERMIT for demolition or renovation must contain an Asbestos notification statement that indicates the owner's or operator's responsibility to comply with the provisions of (§) F.S. 469.003 and to notify the Department of Environmental Protection of his/her intentions to remove asbestos, when applicable, in accordance with state and federal law.

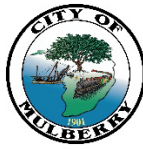

City of Mulberry Building Department Asbestos Disclosure Statement

A permit must be obtained from the Building Division prior to commencing ANY demolition work. Septic Tanks require a separate Abandonment Permit issued by the Polk County Health Department prior to issuance of the Demolition Permit.

Disclosure Statement: State law requires asbestos abatement to be done by licensed contractors. You have applied for a permit under an exemption to that law. The exemption allows you, as the owner of your property, to act as your own asbestos abatement contractor even though you do not have a license. You must supervise the construction yourself. You may move, remove, or dispose of asbestos-containing materials on a residential building where you occupy the building and the building is not for sale or lease, or the building is a farm outbuilding on your property. If you sell or lease such building within 1 year after the asbestos abatement is complete, the law will presume that you intended to sell or lease the property at the time the work was done, which is a violation of the exemption. You may not hire an unlicensed person as your contractor. Your work must be done according to all local, state, and federal laws and regulations which apply to asbestos abatement projects. It is your responsibility to make sure that people employed by you have licenses required by state law and by county or municipal licensing ordinances.

6TH Edition Florida Building Code-105.3.6 Asbestos removal.

Moving, removal, or disposal of asbestos-containing materials on a residential building where the owner occupies the building, the building is not for sale or lease, and the work is performed according to the owner-builder limitations provided in this paragraph. To qualify for exemption under this paragraph, an owner must personally appear and sign the building permit application. The permitting agency shall provide the person with a disclosure statement in substantially the following form:
